I, the undersigned, being of lawful age, for the sole consideration of being granted the opportunity to participate in playing paintball at Spokane Paintball Club, does hereby and for his/her heirs, executors, administrators, personal representatives, successors and assigns release, acquit, and forever discharge in the United States of America and the owner of the property, Spokane Paintball Club LLC, its agents, servants, successors, personal representatives, heirs, executors, administrators, assigns and all other persons, firms, corporations, associations, or partnerships of and from any and all claims, actions, causes of actions, demands, rights, damages, costs, loss of service, expenses and compensation whatsoever, which the undersigned now has or which may hereafter accrue or result from on account of or in any growing out of any and all known and unknown, foreseen and unforeseen, bodily and personal injuries and property damage and the consequences thereof resulting or to result or which may result from any accident, casualty, or event which may or did occur for any reason in connection with or arising out of or on account of the undersigned's participation in simulated combat situations, whether as contestant or observer, held on the date of execution hereof.
